. Board Meeting Minutes



October 24, 2012

The YTCA, Inc. met via telephone conference call. Board members present: Cheryl Rangel, Julie Howard, Robert Owen, Kathy Weems, Barb Bedsted, Lisa Bridgewater, Carolyn Hensley, Bill Hinds and Pamela Wengorovius. President Rangel called the meeting to order at 8:35 P. M. EST.

MINUTES: The minutes from the September 24, 2012 board meeting have been approved by majority. Approving: Rangel, Howard, Owen, Weems, Bedsted, Bridgewater, Hinds, Wengorovius. Not approving: Hensley.

SECRETARY'S REPORT: Secretary Owen reported receiving a letter from the Awards Chair stating she will need more of the new title medallions in a few months. The Treasurer is going to see about placing an order for some more.

The Membership Committee is working on updating the Membership Application and creating a Reinstatement Application to comply with the new Bylaws. Secretary Owen reported on their questions and will relay the Board's answers back to the Chair of the committee.

The Secretary has been receiving emails from the membership concerning the ideas of charging to be on the Breeder Referral, the length of the wait time before being placed on the Breeder Referral, grandfathering international members to give them back their voting rights and volunteering for jobs.

TREASURER'S REPORT: Treasurer Weems reported that as of October 22nd we have a checkbook balance of \$34,826.93, and as of September 30th a money market balance of \$72,984.81.

COMMITTEE REPORTS: Earth Dog: Barb Bedsted reported that Judy Casserberg has been in contact with the AKC and we will not have to do any Earth Dog matches. We can go right to the trial which will be held next Spring in the Twin Cities area of MN.

DQ Committee: Lisa Bridgewater reported she has not yet heard back from Mary Beth at AKC.

Volunteers: Tom Becker and Jennifer White will work on the AKC Complete Dog Book project.

Carolyn Hensley, made a motion seconded by Kathy Weems, to appoint Ken Lambert and Charlie Farrar as Co-Chairs of the Roving Specialty Committee beginning in 2013. The motion passed unanimously.

UNFINISHED BUSINESS: Breeder Contact Page: The Board discussed charging a fee for the Breeder Contact Page only if a member wishes to link to their own website. A strict guideline with rules and regulations for accepting a single breeder web link will be compiled and enforced by the Web Oversight Committee. Bill Hinds made a motion, seconded by Pam Wengorovius, based on member feedback there will be no charge for members being on the Breeder Contact Page unless they have a link to their website and the fee will be \$25.00 if they link. The motion passed unanimously.

The Board discussed the idea of increasing the number of years of required membership before a new member can be listed on the Breeder Contact page of the YTCA website. Lisa Bridgewater made a motion, seconded by Kathy Weems, that it be two (2) years from the date of application for membership before a member can be added to the Breeder Contact Page. The motion passed by majority. Voting yes: Rangel, Howard, Weems, Bedsted, Bridgewater, Hinds. Voting no: Owen, Hensley, Wengorovius.

By-Laws Amendments: The Board discussed the issues of the international members losing their voting rights, not having to own a Yorkshire Terrier when applying for membership, and the \$100.00 fee for filing a formal complaint against another member. President Rangel asked the Board to think about these issues.

NEW BUSINESS: Reserved Seating: President Rangel said last year the reserved seats did not sell out but the last of them finally were sold during the show. We did not expect them to sell out again this year, but they have. Possible ways to add more reserved seats were discussed.

Reserved Grooming: The reserved grooming is going good.

General Membership Meeting: President Rangel discussed the reasons why the general membership meeting is held at the Roving rather than in New York. We can't exclude the Companion Events members from attending the meeting and since we can't hold those events in New York due to space limitations we have the meeting at the Roving where the Companion Events members will be in attendance and can have a vote. It has been suggested that we hold a second meeting in New York after our show. President Rangel said that would not work since we have to clean up and get out of the ballroom per the hotel contract.

Box Ad: Barb Bedsted made a motion, seconded by Pam Wengorovius, that we again put a 1" x 2" box ad in the Puppies USA Annual Magazine at a cost of \$340.00. The motion passed unanimously.

Quick Books Online: Kathy Weems made a motion, seconded by Julie Howard, to hire an accountant to set up Quick Books online for YTCA, and then to use Quick Books online for our book keeping. The motion passed unanimously.

Parliamentarian: Julie Howard made a motion, seconded by Bill Hinds, that the YTCA pay \$200.00 to Patricia Reymann, Professional Registered Parliamentarian, for her service dated October 5, 2012. The motion passed. Voting yes: Rangel, Howard, Owen, Weems Bedsted, Bridgewater, Hinds, and Wengorovius. Abstaining: Hensley.

There being no further business the meeting was adjourned at 9:48 P. M. EST.

Board Meeting Minutes

November 19, 2012

The YTCA, Inc. met via telephone conference call. Board members present: Cheryl Rangel, Julie Howard, Robert Owen, Kathy Weems, Barb Bedsted, Lisa Bridgewater, Carolyn Hensley, Bill Hinds and Pamela Wengorovius. President Rangel called the meeting to order at 8:06 P. M. EST.

MINUTES: The minutes from the October 24, 2012 board meeting have been unanimously approved by Hard Copy vote.

SECRETARY'S REPORT: Secretary Owen reported receiving a call by a member who has not signed up for the Announcement List but feels the announcements should be mailed to her via the US Postal System. All future announcements made on the Announcement List will also be forwarded to our webmaster for inclusion on the Bulletin Board Page of the YTCA Website for anyone to read.

TREASURER'S REPORT: Treasurer Weems reported that as of November 19th we have a checkbook balance of \$33,161.49, and as of October 31st a money market balance of \$73,000.31.

COMMITTEE REPORTS: Breeder Referral: The Board discussed forming a Breeder Referral Committee. Lisa Bridgewater made a motion, seconded by Bill Hinds that the YTCA appoint a Breeder Referral Committee to Review and make suggestions regarding guidelines for members on puppy sales, stud service, rescue and education including contracts, health guarantees, spay/neuter and puppy buyer information. The motion passed unanimously.

Legislative Committee: President Rangel will contact Pat Reynolds to see if she is interested in staying on the committee and become the Chairperson.

Nominating Committee: Bill Hinds made a motion, seconded by Lisa Bridgewater, that Kathleen Kolbert be nominated for chairman of the nominating committee. The motion passed unanimously.

UNFINISHED BUSINESS: Bylaw Amendments: As soon as our new Official List has more members, the Board will poll the members about possible Bylaw Amendments.

New Membership Form: The Membership Committee is working on updating the Membership Application to add the changes that are required with the new Bylaws. Secretary Owen will contact the committee chair for an update.

Membership Renewal Form: Treasurer Weems is working on creating a new Membership Renewal Form and it should be ready by renewal time.

AKC Flyer: The Board discussed several parts of the flyer and chose the wording for the Introduction, and the sections on grooming, health and vet checks. Barb Bedsted will write the whole thing up and send to the Board for approval before it is sent to the AKC to be distributed to new puppy owners.

NEW BUSINESS: Reserved Seating: President Rangel reported that the checks have been received from Linda Thompson for the reserved seats in New York. There will not be any second row reserved seats as had been discussed earlier.

Reserved Grooming: The reserved grooming is doing excellent with \$1,495 received so far. It looks like everybody will be accommodated.

Memphis Specialty Date: The Memphis Roving Specialty date has been set for September 18-22, 2013.

Baskets for NY Raffle: President Rangel requested each Board Member to encourage their local club and members to donate a basket for New York.

Work Assignments for New York: President Rangel asked Board Members to be thinking about what job they would like to do in New York such as: setting up the ring on Thursday, tearing down the ring on Sunday, working at the Silent Auction table, selling catalogs or collecting admissions.

Directors Awards: The Board discussed giving out Director Awards again this year in New York.

Cocktail Party: Kathy Weems made a motion, seconded by Bill Hinds, that we (YTCA) host a cocktail party for our members in New York City on Saturday February 9, 2012 from 6:00 until7:30. The location of the party will be in the dog show ring. There will be a cash bar. The cost to YTCA will be \$3756.19. That cost will include food, waiters, gratuity, taxes, bartender, and cashier. The motion passed unanimously.

Grants: Barb Bedsted made a motion, seconded by Kathy Weems, to support the following: After considering the grants available with AKC Canine Health Foundation the YTCA Health Committee is recommending that we donate money in our Donor Advised Fund with the AKC/CHF to the following grants. Our primary criteria for selecting grants is their impact on our breed. As of 11/1/12 we had \$4055. in our Donor Advised Fund. The motion passed unanimously.

Donation: Barb Bedsted made a motion, seconded by Bill Hinds, that YTCA donates \$500 to the hurricane Sandy relief fund being run by the AKC Humane Fund. The motion passed unanimously.

Medallions: Treasurer Weems reported on the price of the new title medallions as follows: ordering 500 will make them cost \$3.94 each and ordering 1,000 will make them cost \$3.82 each. She will follow up by contacting the Awards Chair to find out how many are sent each year.

There being no further business the meeting was adjourned at 9:27 P. M. EST.

The YTCA, Inc. met via telephone conference call. Board members present: Cheryl Rangel, Julie Howard, Robert Owen, Kathy Weems, Barb Bedsted, Lisa Bridgewater, Bill Hinds and Pamela Wengorovius. Absent: Carolyn Hensley. President Rangel called the meeting to order at 8:05 P. M. EST.

MINUTES: The minutes from the November 19, 2012 board meeting have been approved by majority by Hard Copy vote. Voting yes: Rangel, Howard, Owen, Weems, Bedsted, Bridgewater, Hinds, Wengorovius. Not voting: Hensley.

SECRETARY'S REPORT: Secretary Owen reported that Jean Fournier is no longer judging so she can't fulfill her contract to judge our show in New York. Tim Catterson is next on the 2013 judge's list and will be contacted to see if he will judge. The Secretary also reported that the Trophy Donor list has been sent for publication in the NY Catalog.

TREASURER'S REPORT: Treasurer Weems reported that as of December 20th we have a checkbook balance of \$32,349.80, and as of November 30th a money market balance of \$73,015.31. President Rangel asked the Board to be thinking about making a donation with some of the funds. Board members are to come up with ideas of possible donations.

COMMITTEE REPORTS: Health: Barb Bedsted, Chair, reported that everything is being prepared for holding a Patella, and Microchip Clinic in New York. She stated Joanie Carl reported the companion event calendar has so far brought in \$1,053.70 in profit after expenses which is better than last year.

Website: The Board is working on setting up a Website Committee to work on updating the website. Bill Hinds reported that Stephen Glass and Lisa Farmer have been contacted and have agreed to be on the committee. The Board decided to have the two of them brainstorm and come up with a job description for the committee before the rest of the committee is named.

Breeder Referral: The new Breeder Referral committee is composed of Cindy Whitehead, Chair (MS), Donna Bird (TX), Rosane Fett (TX), Cynthia Mattoni (MI) and Cindy Richardville (IL). This committee will review and make suggestions regarding guidelines for members on puppy sales, stud service, rescue and education including contracts, health guarantees, spay/neuter and puppy buyer information. President Rangel asked the Board to think about anything else that should be included in the new committee's job description.

UNFINISHED BUSINESS: Bylaw Amendments: The Board has gotten word that petitions are being circulated concerning amending the Bylaws allowing foreign members the right to vote, and reinstating the requirement of owning a Yorkshire Terrier when applying for membership. The Board will start a discussion and poll on the new Official YTCA Group List.

NEW BUSINESS: Reserved Seating: President Rangel reported that second row reserved seating will be for Sunday only.

Reserved Grooming: The reserved grooming is sold out.

Work Assignments for New York: President Rangel asked Board Members to let her know when we're willing to work on Sunday. There are many jobs to be done such as: tearing down the ring, working at the silent auction table, selling catalogs, collecting admissions, working with the health clinic or working with trophies.

Medallions: Kathy Weems made a motion, seconded by Barb Bedsted, that we order and buy 500 medallions to be given out by YTCA when a member finishes a Title. The member may choose to receive the Medallion or not. Voting YES: Rangel, Howard, Owen, Weems, Bedsted, Bridgewater, Hinds, Wengorovius. ABSENT: Hensley.

Breed Flyer: Pam Wengorovius made a motion, seconded by Barb Bedsted, that we approve the final version of the AKC Breed Flyer and send it to AKC for distribution. Voting YES: Rangel, Howard, Owen, Weems, Bedsted, Bridgewater, Hinds, Wengorovius. ABSENT: Hensley.

Pam Wengorovius made a motion, seconded by Barb Bedsted, to approve the payment to AKC for distribution of our new Breed Flyer for the \$150.00 start up charge plus an annual payment to AKC covering the \$.03 per flyer that they send out with registrations. Voting YES: Rangel, Howard, Owen, Weems, Bedsted, Bridgewater, Hinds, Wengorovius. ABSENT: Hensley.

Dog Fancy AD: Barb Bedsted made a motion, seconded by Pam Wengorovius, that we renew our ad in Dog Fancy. The cost for 12 months is \$42/issue for a total of \$504. If we renew now we will get an additional two months free. Voting YES: Rangel, Howard, Owen, Weems, Bedsted, Bridgewater, Hinds, Wengorovius. ABSENT: Hensley.

There being no further business the meeting was adjourned at 9:42 P. M. EST.



Applicants must be at least eighteen (18) years of age.

The purpose of this Fund is to allow fanciers of the Yorkshire Terrier Breed an opportunity for additional monetary assistance in furthering their education. Roberta Rothenbach was an avid supporter, breeder, exhibitor and mentor for these dogs and their owners. One of her greatest joys was in watching novices come up through the ranks and achieve success in all of their endeavors.

Payment in the amount of \$500.00 (five hundred dollars) will be made each August directly to the named institution, university, college or trade school for post-secondary educational expenses of two (2) separate individuals whom are chosen among the list of applicants.

Please read and follow the application procedure carefully and completely. A committee of about eight people, including a representative from the YTCA Board, will review the application. Winners will be notified no later than July 15th each year.

Deadline for receiving the application and essay is May 30th

A scholarship will be awarded one time only to any individual. Scholarship applications may be resubmitted annually. Note: <u>No applications will be held for review in subsequent years.</u>

Each year, the Foundation evaluates grants and researches health issues that have so far escaped definitive causes and/or solutions. These grants are reviewed by our board members to determine which are the most beneficial to our breed. The members carefully consider several factors in each grant in order to maximize research dollars. They look first at the potential of the research to benefit Yorkshire Terriers in particular and all dogs in general. Next, we consider the previous success of the research conducted by the principal investigators. The Foundation also supports grants which help new veterinarians, veterinarian students and academicians get started in their chosen field of research.

Because one of the two grants we voted to sponsor this year was discontinued and we had a budget for two grants, the Grants Committee and the Board went back to the drawing board to see what else may be available and of interest. We are pleased to announce that we have now agreed to sponsor:

01731: Potential association between altered gut microbiota and development of meningoencephalomyelitis of unknown etiology (MUE) in dogs

This grant is for \$31,104 with AKC Canine Health Foundation (CHF). The Researcher is Dr. Nick Jeffery, BVSc. lowa State University, and will run from January 1, 2013 to December 31, 2014. It intends to benefit several breeds, including the Yorkshire Terrier. This project is aimed at finding a cause of meningoencephalomyelitis of unknown etiology, otherwise known as 'MUE." which is a summary term for diseases such as 'GME.' This group of conditions causes serious neurologic disease in dogs, especially small breeds, including blindness, loss of balance, seizures and paralysis -- but the cause is currently unknown. A recent experimental breakthrough has incriminated bacteria in the digestive system as triggers for a similar disease in laboratory mice and rats. The main purpose of the project is to find out whether imbalances in the number or type of digestive system bacteria might also be a cause for MUE in dogs. If it is true, it would open a whole new avenue of approach to treatment of affected dogs and might also produce information useful for treating neurologic disease in humans. To carry out this investigation, the numbers will be compared as well as the type of bacteria with what they find in fecal samples from unaffected dogs. Since they will be examining many dogs with MUE, they can ask their owners other questions about their dogs' recent medications and medical history to determine whether there are other risk factors that might be associated with MUE.

This area of research is also under investigation by NC State and UFL because they, too, have found some evidence of bacterial association with MUE. The Researcher, Dr. Nicholas Jeffery, received his BVSc from the University of Bristol (1981) and his PhD from the University of Cambridge (1997) as well as numerous other Certificates and Diplomas. Dr. Jeffrey has been a lecturer and senior lecturer in Clinical Neurology at the University of Cambridge from 2000 and until 2011. He was also their Professor of Veterinary Clinical Studies. Currently, he is a Professor of Veterinary Clinical Science at lowa State University. His vitae is quite impressive and because this disease effects our breed, we have decided to lend our monetary support to the project.

The Foundation is very fortunate to have such a hard-working and dedicated TEAM. Our grants committee is chaired by Jacqueline "Jackie" Spencer who is well versed in scientific research. Jackie is an Assistant Professor of Biology with a background in animal behavior and comparative medicine research. Besides teaching microbiology, she is currently working on a National Science Foundation grant. She tries to pair up the Yorkie health issues of most interest to breeders and owners with the current grants that need funding. Besides looking at the research methodology for grants under consideration, she also looks into the background of the principal investigators to determine their previous research successes.



Smoky's Heroics Honoured

A LASTING tribute to Smoky the Yorkshire Terrier will be unveiled in the Royal Brisbane and Women's Hospital grounds today, in recognition of her work during World War II.

A sculpture of the little pooch, sitting in a serviceman's helmet, will be a permanent reminder of her contribution to comforting troops with "shell shock", now known as post-traumatic stress disorder.

Her American owner, former US airman, Bill Wynne, 90, described his furry friend, who died in 1957, aged 14, as the "world's first therapy dog".

She was about 10 months old when an American serviceman found her abandoned in a New Guinea foxhole in February, 1944. Mr Wynne later bought her for two Australian pounds.

"She went through about 150 air raids. I took her on 12 combat missions with me," he said by email from his home near Mansfield, Ohio.

Smoky's work as a therapy dog began in a US tent hospital in Nadzab, New Guinea, where Mr Wynne was being treated for dengue fever in July, 1944.

She accompanied nurses on their rounds and, when in Brisbane on leave, the Red Cross asked Mr Wynne to take his dog to two military hospitals, including one on the site of the RBWH.

Smoky's story would have remained untold in Australia if not for Nigel Allsopp, a Brisbane police dog handler and Australian war animal historian, who saw a sculpture of her last year in Laguna Beach, California, and contacted Mr Wynne

RESCUE - The Good, the Bad, & the Ugly

Rescue is an eye opening experience, there's no doubt about that. After my husband had a stroke it was obvious that my dog showing days were over. I was needed more at home, and frankly my arthritis was telling me the same story.

But what does a former Yorkshire Terrier Exhibiter do with their time? I couldn't give up my love of the breed, and I always felt that if I chose to breed puppies I should also be prepared to support Rescue in some way. Up until 2004 my support was mainly monetary, but when the health of my husband intervened and I was no longer involved in showing, I decided I would join the Rescue Team of the Central Florida Yorkshire Terrier Club.

When going into the working team my thoughts were so different than the actual facts of what occurs in Rescue. There are so many different scenarios of why Yorkies are signed over to Rescue. Florida being a retirement community state, many of the Yorkies come to us from elderly owners who can no longer keep their dog for various reasons. But this isn't always the case. Many times, they come to us because the owners cannot afford expensive veterinary care.

My first experience occurred when a local veterinarian called to ask if we could take an eighteen month female that had injured legs believed to be caused by young children abusing her. My husband and I were at the vet's office within fifteen minutes to learn the story of how a man brought the dog in for care, and in learning that that both front legs had been broken and would require expensive surgery ordered the dog to be "put down". The veterinarian convinced him to sign the dog over to Rescue. I'll never forget the look in that little dog's eyes as we cautiously picked her up and took her home.

It took several surgeries, some while in Rescue and further after she was placed in a new home, before this little dog was back to her usual happy self. Her new owners already had one Yorkie and the two dogs became fast friends. I've visited several times, and it is so heartwarming to see the bond between the family of humans and canines.

A really hurtful experience was when I was called by a "no kill" shelter in a neighboring county. They had a female Yorkie they believed to be eight or nine years old, she was scared in the over populated shelter, so would I pick her up immediately. They told me that her owner had passed away and the family couldn't take the Yorkie.

The shelter parking lot was swamped with cars and the shelter attendants were signing release forms as quickly as they good because they were indeed over populated. The dear little Yorkie that saw staring out of the bars of her cell was terrified by the larger, louder, dogs in the cage next to her. Without checking her out, I quickly signed the forms accepting responsibility, wrapped her in a towel and then placed her in a crate for the hour long trip home. Along the way I had to pass my veterinarian's office, so I pulled in to ask for a quick examination of "Princess". Imagine my horror when unwrapping the towel and doing a quick underbody examination we learned that Princess had a couple of large mammary tumors. X-rays confirmed that this dear little dog was full of cancer and undoubtedly in pain.

This was my worst nightmare and I was faced with making a decision I absolutely hated. After going over the pros and cons, learning that Princess had very little time left in this world, and that time would be filled with pain I had to concede to the veterinarian's advice. The only consolation I had was that she was held in my caring arms as she crossed the Rainbow Bridge, instead of that large impersonal overcrowded shelter. I cried buckets.

Rescue doesn't just care for the unwanted, discarded, or sick dogs. We often come to the aid people in need of temporary support as was the case when we were contacted by a Families & Children's Welfare department. A young widow lost her job and was in the process of losing her home. In order for her to find work, she and her pre-teen aged daughter had to move out of state. In the meantime they were living in a motel room where they couldn't keep their two dogs, one a Yorkie and the other a Shih Tzu/Yorkie cross. They had lost so much already, the county officials didn't want them to lose their canine family too if it could be avoided. This was my first experience of receiving such a call, but I was impressed that a County Department was going out of its way it keep a family of humans and canines intact until they could support them. So these two little dogs arrived at the home of one of our Rescuers, and spent two months enjoying the hospitality before being transported out of state to join the delighted owner who had managed to find a job and a new home.

Each case is different, each one is a challenge, and most result in happy endings. Not everyone is equipped or able to work with Rescue, but here are a few areas with job descriptions where people can help.

<u>Rescue Retrieval</u> – Picking up a dog that is being turned in to Rescue. Obtaining paperwork that authorizes the release of the dog.

<u>Transportation</u> – Very often we pick up a dog that can be re-housed in another county or state and we seek transportation from someone who is able to do this. On occasion, a dog is being transported to an area with veterinary care that specializes in whatever care the dog requires.

<u>Temporary housing</u> – Daily care of the dog (s). Transporting for veterinary care including spay/neuter pre and post operative. Usually less than thirty days is required.

<u>Foster Care</u> – Long term foster care for a dog that is difficult to place in a new home either because of age, disability, or health issues. Lately we have even been asked to do temporary fostering in spouse abuse cases to ensure that the dog is not injured or traumatized.

<u>Record Keeping</u> – Logging in new rescues, listing on the website for availability, recording all veterinary care past and present, accounting/bookkeeping.

<u>Reviewing Applications to Adopt</u> - Applications are received via web site, over the telephone, or in writing from persons interested in adopting a rescue. Just as with placing one of your own puppies, we need to be sure there is a good match between people and dog(s). Application forms are completed, and references checked out before the next step takes place.

<u>Home Inspection</u> – After the application has been approved, the home inspection takes place. Ideally we want a Yorkie to go where there is a fenced yard, but they are also an ideal dog for an apartment, so good common sense is important with any inspection.

<u>Adoption</u> – The most rewarding part of the Rescue job is placement, taking the dog to its new home and signing over to the new owner. Temporary food supplies and care instructions go along with the dog. The new owner will always be given a name and phone number to contact for advice.

<u>Follow-up</u> – Two follow up visits are usually done, one announced, and one unannounced. We like to wait at least one month before doing the first visit to allow the dog time to adjust.

<u>Emergency Assistance</u> – Some people are not able to be a permanent member of the Rescue team, but in an Emergency will be willing to jump in and help. Hurricanes, floods, tornadoes, sudden illness, are all types of emergencies. When emergencies of a large scale occur such as hurricanes/floods, that is when transportation, equipment, and veterinary supplies will be needed, and we will need all the help we can get to accumulate and distribute those supplies.

As you can see from the above, even if you are unable to be a Rescue Foster Home, there are other opportunities to contribute. And let's not forget helping with fundraising. It only takes one major case, one major surgery, or one storm, to use up the bank account or supplies.

Rescue Teams deserve a lot of credit for the work they do, so next time you pass a Rescue booth at your specialty or dog show, say hello and let them know they are appreciated

Dear Members.

As reported previously via individual email to all the members and in the EExpress, YTCA sent the following DQ wording to AKC for consideration. This has been a very long process. The DQ committee started out with soliciting input from members via posting on the Official Notice List and the EExpress. We appreciate those who responded and certainly took their suggestions in coming up with the wording. The suggestions have all been kept on file. We had proposed the following wording which we had sent out to the membership and published in the EExpress. We received notice from AKC that a member of their Board objected to the sentence regarding the colors on the head of a younger dog as highlighted below. They felt this would require rewriting the color portion of the Standard.

<u>Disqualify</u> - colors or color patterns not described in the standard. A coat that is solid in color. <u>Particolored</u> or white patches on any part of the body other than the chin and forechest, at any age. <u>Not to be</u> confused with the pale gold, or silver gray color, which are normal colors found on the head of a younger

dog, as they mature to tan. All deviations listed under COLORS in the Standard, shall be faulted to the extent of the deviation, but NOT disqualified.

After going back and forth with AKC, we were informed that the following wording should be acceptable to their Board. We felt this kept the intent of the DQ clarified.

Any color deviation listed under COLORS in the Standard, shall be penalized to the extent of the deviation, but NOT disqualified. Disqualify - colors or color patterns not described in the standard. A coat that is solid in color. Parti-colored or white patches on any part of the body other than the chin and forechest, at any age.

At the October Board meeting of AKC their Board approved that the proposed change as follows was accepted by the AKC Board. It will be published on the November Secretary's page for comment. The wording from the AKC Board minutes was:

Proposed Yorkshire Terrier Breed Standard Revision

The Board reviewed proposed revisions to the color and disqualifications sections of the Yorkshire Terrier breed standard as submitted by the Yorkshire Terrier Club of America. Following a motion by Mr. Arnold, seconded by Dr. Garvin, it was VOTED (unanimously) that the proposed revisions will be published in the AKC Secretary's Page for comment.

This is part of the AKC process. Following this, should all go well, the Proposed DQ Revision will require a vote by the YTCA membership.

This is how it would look in the context of the Standard:

Colors

Puppies are born black and tan and are normally darker in body color, showing an intermingling of black hair in the tan until they are matured. Color of hair on body and richness of tan on head and legs are of prime importance in adult dogs, to which the following color requirements apply: Blue: Is a dark steel-blue, not a silver-blue and not mingled with fawn, bronzy or black hairs. Tan: All tan hair is darker at the roots than in the middle, shading to still lighter tan at the tips. There should be no sooty or black hair intermingled with any of the tan. Any color deviation listed under COLORS in the Standard, shall be penalized to the extent of the deviation, but NOT disqualified. Disqualify - colors or color patterns not described in the standard. A coat that is solid in color. Parti-colored or white patches on any part of the body other than the chin and forechest, at any age.

Below is the complete Standard with the Revised Proposed DQ:

From the Yorkshire Terrier Standard (Revised Proposed DQ in BLUE, Current DQ in RED) General Appearance

That of a long-haired toy terrier whose blue and tan coat is parted on the face and from the base of the skull to the end of the tail and hangs evenly and quite straight down each side of body. The body is neat, compact and well proportioned. The dog's high head carriage and confident manner should give the appearance of vigor and self-importance.

Head

Small and rather flat on top, the skull not too prominent or round, the muzzle not too long, with the bite neither undershot nor overshot and teeth sound. Either scissors bite or level bite is acceptable. The nose is black. Eyes are medium in size and not too prominent; dark in color and sparkling with a sharp, intelligent expression. Eye rims are dark. Ears are small, V-shaped, carried erect and set not too far apart.

Body

Well proportioned and very compact. The back is rather short, the back line level, with height at shoulder the same as at the rump.

Legs and Feet

Forelegs should be straight, elbows neither in nor out. Hind legs straight when viewed from behind, but stifles are moderately bent when viewed from the sides. Feet are round with black toenails. Dewclaws, if any, are generally removed from the hind legs. Dewclaws on the forelegs may be removed.

Tail

Docked to a medium length and carried slightly higher than the level of the back.

Coat

Quality, texture and quantity of coat are of prime importance. Hair is glossy, fine and silky in texture. Coat on the body is moderately long and perfectly straight (not wavy). It may be trimmed to floor length to give ease of movement and a neater appearance, if desired. The fall on the head is long, tied with one bow in center of head or parted in the middle and tied with two bows. Hair on muzzle is very long. Hair should be trimmed short on tips of ears and may be trimmed on feet to give them a neat appearance.

Colors

Puppies are born black and tan and are normally darker in body color, showing an intermingling of black hair in the tan until they are matured. Color of hair on body and richness of tan on head and legs are of prime importance in adult dogs, to which the following color requirements apply: Blue: Is a dark steel-blue, not a silver-blue and not mingled with fawn, bronzy or black hairs. Tan: All tan hair is darker at the roots than in the middle, shading to still lighter tan at the tips. There should be no sooty or black hair intermingled with any of the tan. Any color deviation listed under COLORS in the Standard, shall be penalized to the extent of the deviation, but NOT disqualified. Disqualify - colors or color patterns not described in the standard. A coat that is solid in color. Parti-colored or white patches on any part of the body other than the chin and forechest, at any age.

Color on Body

The blue extends over the body from back of neck to root of tail. Hair on tail is a darker blue, especially at end of tail.

Headfall

A rich golden tan, deeper in color at sides of head, at ear roots and on the muzzle, with ears a deep rich tan. Tan color should not extend down on back of neck..

Chest and Legs

A bright, rich tan, not extending above the elbow on the forelegs nor above the stifle on the hind legs.

Weight

Must not exceed seven pounds.

Disqualifications:

Current DQ

Any solid color or combination of colors other than blue and tan as described above. Any white markings other than a small spot on the forechest that does not exceed 1 inch at its longest dimension.

Revised Proposed DQ

Any color deviation listd under COLORS in the Standard, shall be penalied to the extent of the deviation, but NOT disqualified. Disqualify - colors or color patterns not described in the standard. A coat that is solid in color. Parti-colored or white patches on any part of the body other than the chin and forechest, at any age.

<u>IN AN EMERGENCY SITUATION</u> such as a heart attack, drowning or fall, the victim should be responded to in an appropriate manner. Administer CPR (if certified) and an ambulance should be called by dialing 911.

Try to notify next of kin or a friend traveling with the group.

DISASTER EVACUATION PROCEDURES

- 1.In the case of a severe weather storm or other instances not including a fire evacuation, leave your room immediately and head for the nearest stairwell.
- 2. Go to the Main Lobby area of the hotel and wait for further instructions
- 3. Do not stand near any windows

- 4. Utilize the same system for removing your dogs from the room (a large pillowcase) unless you are able to carry the crate with you. Take your room key
- 5. Follow instructions from hotel management and/or fire and police personnel

DOG EVACUATION PROCEDURES

- 1. In the case of a fire or other evacuation, have a king size pillowcase nearby. Place as many dogs as possible in the pillowcase and twist the top. This will enable you to carry them out of the building safely. There is no chance of suffocation to the dogs inside the case
- 2. It's a good idea to keep a few leads inside the case. When you reach the outside you have some way to keep control of the animals
- 3. Do not endanger your life or the lives of others in your room by spending time searching for your dogs. If they are properly penned or crated, you should be able to gather them quickly and easily

Official Standard of the Yorkshire Terrier

As with all purebred dogs recognized by the American Kennel Club, there is an approved Breed Standard for Yorkshire Terriers. This standard of perfection is a written description of how the ideal Yorkshire Terrier should look. All responsible breeders strive to produce dogs that conform to this Breed Standard. Yorkshire Terriers with major deviations from that Standard in appearance should not be bred.

General Appearance

That of a long-haired toy terrier whose blue and tan coat is parted on the face and from the base of the skull to the end of the tail and hangs evenly and quite straight down each side of body. The body is neat, compact and well proportioned. The dog's high head carriage and confident manner should give the appearance of vigor and self importance.

Head

Small and rather flat on top, the skull not too prominent or round, the muzzle not too long, with the bite neither undershot nor overshot and teeth sound. Either scissors bite or level bite is acceptable. The nose is black. Eyes are medium in size and not too prominent; dark in color and sparkling with a sharp, intelligent expression. Eye rims are dark. Ears are small, V-shaped, carried erect and set not too far apart.

Body

Well proportioned and very compact. The back is rather short, the back line level, with height at shoulder the same as at the rump.

Legs and Feet

Forelegs should be straight, elbows neither in nor out. Hind legs straight when viewed from behind, but stifles are moderately bent when viewed from the sides. Feet are round with black toenails. Dew claws, if any, are generally removed from the hind legs. Dew claws on the forelegs may be removed.

Tail

Docked to a medium length and carried slightly higher than the level of the back.

<u>Coat</u>

Quality, texture and quantity of coat are of prime importance. Hair is glossy, fine and silky in texture. Coat on the body is moderately long and perfectly straight (not wavy). It may be trimmed to floor length to give ease of movement and a neater appearance, if desired. The fall on the head is long, tied with one bow in center of head or parted in the middle and tied with two bows. Hair on muzzle is very long. Hair should be trimmed short on tips of ears and may be trimmed on feet to give them a neat appearance.

Colors

Puppies are born black and tan and are normally darker in body color, showing an intermingling of black hair in the tan until they are matured. Color of hair on body and richness of tan on head and legs are of prime importance in adult dogs, to which the following color requirements apply: BLUE: Is a dark steel blue, not a silver blue and not mingled with fawn, bronzy or black hairs. TAN: All tan hair is darker at the roots than in the middle, shading to still lighter tan at the tips. There should be no sooty or black hair intermingled with any of the tan.

Color on Body

The blue extends over the body from back of neck to root of tail. Hair on tail is a darker blue, especially at end of tail.

Head fall

A rich golden tan, deeper in color at sides of head, at ear roots and on the muzzle, with ears a deep rich tan. Tan color should not extend down on back of neck.

Chest and Legs

A bright, rich tan, not extending above the elbow on the forelegs nor above the stifle on the hind legs.

Weight

Must not exceed seven pounds.

Disqualification

Any solid color or combination of colors other than blue and tan as described above. Any white markings other than a small white spot on the forechest that does not exceed 1 inch at its longest dimension.

Yorkshire Terrier Club of America, Inc. Code of Ethics

PREFACE

As a member of the Yorkshire Terrier Club of America, inc., I agree to uphold the principles of the Club's Constitution, Bylaws, Code of Ethics and Code of Conduct and will protect the interests of the Yorkshire Terrier in the manner reflecting credit to myself, the Breed, and the Club. I agree to comply with all AKC Rules and regulations.

While understanding that the circumstances facing each individual member are different, the Codes set forth a standard of canine husbandry all Club members should strive to achieve.

The code is intended to provide each member fundamental behavior principles which will guide the Club, the Yorkshire Terrier breed and each member well in nearly all situations.





Yorkshire Terrier Club of America, Inc. Code of Ethics

- 1) A breeder-member shall strive to conform to the Yorkshire Terrier Standard as approved by the American Kennel Club, to improve progeny, and to reduce faults to a minimum.
- 2) Members shall comply with the rules of the American Kennel Club concerning record keeping and the registration, identification, sale, and transfer of dogs.
- 3) Members shall refer potential puppy purchasers to other reputable breeders and be helpful and courteous to those who request information about the breed
- 4) All contractual terms and conditions relating to Yorkshire Terriers shall be reduced to writing and shall be honored by a member..
- 5) All stud dogs and bitches shall be screened prior to breeding for both infectious and hereditary diseases using the currently accepted and available techniques.
- 6) A breeder-member selling puppies or offering stud services shall fully disclose to potential clients any serious or disabling hereditary defects, including the reasonable possibility of such defects. Such health defects shall be stated in writing.
- 7) A member shall not defame another member or the YTCA nor seek to impair a member's or the YTCA's reputation, provided however, a member shall report any serious situation, created by another member, that is detrimental to the breed or is inconsistent with these principles. This report should be in writing and sent to the Club Secretary.
- 8) A member's advertising: -shall be professional in appearance and location; -may refer to YTCA membership but may not misuse YTCA membership to attempt to enhance integrity or the quality of stock; -shall not contain any misleading photograph or other graphic materials; -shall not use terms such as "teacup", "tiny specialists", "doll faced", or similar terminology.
- 9) Members shall sponsor an applicant for membership only if the member has personally known the applicant for a minimum of two years. At least one of the sponsoring members must have visited the applicant's facility one or more times during the two years immediately preceding the application date. Sponsorship is not to be taken lightly. Each sponsor must understand YTCA and the Yorkshire Terrier are represented by each and every member individually, and careful consideration should be given to each candidate.

Yorkshire Terrier Club of America

CODE OF CONDUCT

- 1) Assistance and encouragement shall be willingly offered by members to Show Novices and others needing advice and guidance. The welfare of the breed will be in their hands in the future.
- 2) All dogs will be kept under safe and sanitary conditions, be given proper nutrition, protection, and maximum health care including regular inoculations as advised by the member's veterinarian.
- 3) Healthy spacing between litters will be a priority and unspayed bitches will be protected from unplanned matings. Bitches will in no case be bred before their second heat or before they are at least eighteen (18) months of age, whichever comes first, nor be placed at risk by an unreasonable number of cesarean sections and then only with the concurrence of a veterinarian.
- 4) Puppies will not be sold or consigned to pet stores, agents, or other commercial enterprises nor sold to disreputable breeders, and neither puppies, adult dogs, nor stud services will be offered as prizes or for raffles.
- 5) Prospective buyers will be screened as thoroughly as possible to determine their intent, as well as their ability and interest in providing a safe, adequate, loving environment and a long term relationship with a puppy or adult dog.
- 6) All puppies and dogs offered for sale will be sold with written sales agreements to include clear terms and conditions and be signed by the seller and buyer. The contract will request that the seller be contacted in the event that at any time the owner is unable to keep the dog, it will be the obligation of the seller to assist in the placement of the dog in question.
- 7) Purchasers will be required to neuter/spay all puppies sold as pets. If specified in the written sales contract, the seller will promptly release limited registration forms upon receipt of a veterinarian's certification of such spaying or neutering.
- 8) All puppies leaving the breeders possession will be a minimum of twelve (12) weeks of age to facilitate adequate socialization as well as appropriate emotional and temperament development through interaction with siblings, dam and other dogs.
- 9) Breeders will provide puppy buyers with written details of feeding, general care, date and types of a minimum of two (2) inoculations, as well as dates of wormings, grooming instructions, etc. and be available to offer future advice as needed.
- 10) Stud service will be offered only by and to AKC Full Registered, or registered with an AKC approved foreign registry, healthy, mature dogs and bitches, respectively, and only of sound temperament. The dogs and bitches should be free of serious congenital and hereditary defects. Stud service will be refused for any mating which is considered to not be in the best interest of the breed which includes dogs and bitches with Q Registration in their pedigrees, and dogs and bitches of any color, or combination of colors not specified in the standard. Members will not sell dogs of such colors as exotic or rare.
- 11) Animals recently exposed to the risks of infectious diseases and bitches with nursing whelp will not be exhibited.
