Board Meeting Minutes

July 22, 2013

The **YTCA, Inc.** met via telephone conference call. Board members present: Cheryl Rangel, Julie Howard, Robert Owen, Charlie Farrar, Barb Bedsted, Lisa Bridgewater, Carolyn Hensley, Bill Hinds and Pamela Wengorovius. President Rangel called the meeting to order at 8:06 P. M. EST.

MINUTES: The minutes from the June 10, 2013 Board Meeting have been approved by majority by Hard Copy Vote and the minutes from the June 17, 2013 Board Meeting have been unanimously approved by Hard Copy Vote.

SECRETARY'S REPORT: Secretary Owen reported receiving a notice from Patti Strand about renewing our membership in NAIA.

The AKC Parent Club Medallions Pledge Form and check have been sent to AKC for the medallions that will be given at the AKC/Eukanuba dog show. We are waiting to hear back from the Public Education Chair about who she has secured to be in charge of the Meet the Breeds Booth at the AKC/Eukanuba show.

There is still time to get the reduced registration fee to send a representative to the AKC/CHF Conference.

TREASURER'S REPORT: Treasurer Farrar reported that the checking account currently has a balance of \$37,171.10, and the Money Market has a balance of \$73,121.40. She is sending hard copy letters to the members whose renewal checks are missing.

COMMITTEE REPORTS: DQ Committee: After the election is over another ballot will be sent to the membership for them to vote on the DQ. The same ballot will also contain the voting on Judges Selection and the CHIC requirement. The ballot will use the double envelope system.

Hearing Committee: Due to one of the defendants retaining an attorney, the hearing committee voted to be represented by counsel and took the following motions to the entire board for a vote. Julie Howard made a motion, seconded by Charlie Farrar that the YTCA pay the retainer fee and hourly expenses plus any expenses including airfare, hotel, food, and any incidental expenses in regards to the complaints and subsequent hearings for the attorney to represent the hearing committee and be in attendance for the hearings. The motion passed by majority. Voting Yes: Rangel, Howard, Owen, Farrar, Bedsted, Bridgewater, Hinds, Owen and Wengorovius. Voting No: Hensley.

Julie Howard made a motion, seconded by Bill Hinds, that the YTCA pay all expenses including airfare, hotel, food, rental car, and any incidental expenses for the committee members in regards to the complaints and to attend any subsequent hearings. The motion passed by majority. Voting Yes: Rangel, Howard, Owen, Farrar, Bedsted, Bridgewater, Hinds, Owen and Wengorovius. Voting No: Hensley.

Roving Specialty Committee: Charlie Farrar reported the Conformation Trophies for the Roving Specialty have been paid for and the Companion/Performance trophies have been received. The Welcome Bags and Hospitality are in good shape. The CGC supplies have been received and Eddie Dzuik has been secured to give a presentation on CHIC. Barb Bedsted reported that the Conformation rosettes are being ordered and will run around \$550.00. Pam Wengorovius reported on the Companion/Performance ribbons and that the plain ones will be used for the Toy Group Trials and the new ones for the Yorkshire Terrier trials.

UNFINISHED BUSINESS: Website: Ken Lambert, Chair, requested that we pay GMR to host the new website for the first six months. It should be up by August 1st.

NEW BUSINESS: New York Hotel: We are going forward with the New York show. Two hotels are interested in having us for about the same ballroom fee as we have paid in the past. The suggestion was made to do away with the Friday date and each club could hold their sweepstakes on the morning of their show. The New Yorker Hotel raised their fee so high it was out of the question to keep the show there.

New York Show Committee: It will be up to the new board to name the Show Committee for the New York National Specialty.

Judges Education: Kathleen Kolbert, Judges Education Chair, sent the new requirements from AKC that have to be followed concerning Judges Education and Ringside Mentoring. Ringside Mentors have to be chosen very carefully.

Donation: Julie Howard made a motion, seconded by Bill Hinds, that the YTCA donate \$500.00 to Take The Lead in memory of Carl C Yochum. The motion passed unanimously.

Show Dedication: The Memphis Roving Specialty Show is dedicated to Susan Griffin, and in addition, Bill Hinds made a motion, seconded by Barb Bedsted, that we dedicate the roving held in Memphis 2013 to Carl Yochum and also have a celebration of his life at the New York Specialty. The motion passed unanimously.

Canine Health Foundation Conference: Charlie Farrar made a motion, seconded by Barb Bedsted, that we send Patty Coyne to the Canine Health Foundation's conference with YTCA paying for her airfare and the seminar fee. The motion passed unanimously.

Kennel Name: The Board has been asked to work with Carl Yochum's family in having his kennel name, Tapyocas, retired by AKC. President Rangel will send information to Carl's family as to how to proceed.

NAIA Membership Renewal: Patti Strand's request for the YTCA to renew their membership in the National Animal Interest Alliance was deferred at this time.

AKC Flyer: Barb Bedsted reported that Lisa Thornberg has sent the Flyer to the AKC and we will be billed in the Fall.

There being no further business the meeting was adjourned at 9:02 P. M. EST.

BOARD MEETING MINUTES
Held via Teleconference Call
August 14, 2013

President Cheryl Rangel called the meeting to order at 8:02 pm Eastern Time, with the following Board Members in attendance: Cheryl Rangel (President), Bob Owen (Vice President), Gloria Bloch-Robinson (Secretary), Charlie Farrar (Treasurer), and Directors Carolyn Hensley, Ken Lambert, Cookie Rogan, Helen Scott, Jennie Wright, and assistant to the secretary Leslie Stolfe.

PRESIDENT'S REPORT:

The new board members were welcomed, and thanked for volunteering their services to the Board. They were reminded that a Conflict of Interest policy and a Confidentiality Agreement had to be signed and forwarded to the Secretary as soon as possible. Policies will be sent out via email to everyone, and Pam Wengorovius is in charge of that committee. Policies include that no one serving on the Board shall sponsor anyone for membership, and no one on the Board shall exhibit at the National Specialty in Conformation or Sweeps (there are currently no companion events at the National). Further, no one on the Board will exhibit under any judge who is also on the Board. If as an exhibitor you reach group level and the group judge is a board member, that is permitted. This does not apply to co-ownership, or if someone else is showing your dog.

One other issue addressed was that there will be no discussion regarding any complaints undertaken by the previous board. It would be violating our By-Laws if we discussed what took place under Executive Session with the previous Board in regard to any complaints.

MINUTES OF THE PREVIOUS MEETING:

The minutes of the July 22, 2013 Board Meeting were approved by the majority and a hard copy received.

SECRETARY'S REPORT:

Secretary Gloria Robinson received the following correspondence.

A letter of request was received from the Yorkshire Terrier Club of Greater New York to hold their specialty at the Crowne Plaza Hotel, assuming the contract is signed. The request was unanimously approved.

A letter was received from Kathleen Kolbert regarding the judges' education and the requirements from AKC that went into effect during 2012. Bob Owen explained that mentors for judges' education will have to take a test and the package contains all the forms and information. Since there is too much information to scan, the secretary was asked mail a copy to each board member.

Correspondence was received from the membership committee asking if there is a limit on the number of applicants a member can sponsor at one time. Also discussed was the number of litters produced in a year, and visits by AKC as noted on the application. The Membership Committee is asked to write a draft of changes they suggest and forward the draft to the Board for review.

The secretary reported close to 100 requests via email and regular mail to drop the charges that are currently under consideration. This issue was not discussed as previously stated.

TREASURER'S REPORT

Reconciliation for July is as follows - The Money Market account is \$73,136.93, checking account is \$33,157.20. There are 63 members who have not renewed, 12 of those will be coming in and everything post marked by the 15th will be counted as on time. The deadline was extended due to the election process being late, and there is another thirty day grace after that. Copies of the renewal letters will be sent to the Secretary for updating the roster.

COMMITTEE REPORTS

By-Laws Committee: Volunteers for the By-Laws Committee are Marie Kaufman, Marsha Greene, Sharon McCadam, and Pamela Langstein. There are two amendments requested by members. First, to restore full membership with voting privileges to international members who had their membership paid for the year 2012/2013. New international applicants will not have voting privileges. Second, was that an applicant for membership is required to own a Yorkshire Terrier. Previously there was a possibility of Associate Membership for anyone who does not own a YT but has a great interest in the breed and works in Rescue, or at Shows, etc. Carolyn Hensley made a motion that the By-Laws Committee be approved to review and submit changes for Board Approval, seconded by Gloria Robinson, motion carried.

Carolyn Hensley made a motion to ask for volunteers to review and submit to the Board their suggestions for By-Laws changes, Standing Rules and Standard Operating Procedures for the club. Seconded by Jennie Wright. In discussion it was thought that a lot of things in our By-Laws could be transferred to Standing Rules. Membership did not believe we were getting much support from AKC and therefore they don't have a voice. Standing Rules would give them a voice and an ability to exercise their voice. Some concern was expressed about the cost involved and the needed participation of 20% of the membership to agree. The entire Board agreed that we should include this issue in the mail out to membership, and have an accounting firm handle the returns. Included in the ballot would be an opportunity for members to tell us what they would like to see changed in the By-Laws.

The Roving: There are very few dinner reservations as of today's date, and we also need more attendees for the seminar. Another notice will be sent out. Judges have been confirmed, hotel reservations have been made for agility, obedience, rally, and conformation. There will be a Board Meeting on Wednesday afternoon beginning at 4:30 pm followed by the General Membership Meeting in Memphis. Other regular meetings will be held on the Third Monday of each month. A poll was taken, and everyone agreed.

OLD BUSINESS

Ken Lambert reported the website has been changed in accordance with requests from members regarding Puerto Rico, Rescue Clubs, and people have been notified that changes have been made. There is another image of a dog on the front page, and it is a composite of several different dogs so the actual dog does not exist. Lisa Thornberg did the work.

Newsletter information: The new board members were asked to submit photos of themselves to the Express editors.

NEW BUSINESS

Committee Assignments: We had two resignations from the Companion Events Committee, and we received an email stating that Pam Shelby and Susan Colledge were willing to serve on that committee to fill the spots. Board approval was given.

Cindy Whitehead resigned from the Breeder Referral Committee and ordering the award plaques. We will consult the list of people who have offered to volunteer.

Faye Mitchell has volunteered to serve on the Achievement Awards committee.

A MOTION WAS MADE AND SECONDED TO GO INTO EXECUTIVE SESSION AT 9:15 pm EST

A MOTION WAS MADE AND SECONDED TO CLOSE THE EXECUTIVE SESSION AT 9:32 pm EST

New York Hotel:

We have a contract with the Crowne Plaza in New York. They require an immediate deposit \$1,733.78, and another \$1,733.78 on November 5th. The Greater New York club is paying the same amount on the same dates. The ballroom will cost \$6,000 per day. Dogs may be left unattended in the rooms as long as they are crated or penned. A motion was made by Carolyn Hensley to approve the contract and also to discuss the same contract for 2015 and to send a deposit, seconded by Charlie Farrar, motion carried.

Our sweeps will be held on Sunday morning, Greater New York sweeps will be on Saturday morning to reduce the ballroom cost, and we will revisit this schedule every year as needed. Kathleen Kolbert and Pam Longstein spent time going around New York City to find a hotel and were instrumental in securing this opportunity. Gloria will send out the AKC application as soon as possible.

Carolyn Hensley made a motion to approach AKC for permission to hold a specialty at the Eukanuba specialty. Cheryl will investigate the possibility as well as Roberts Hall in Ohio, and Purina in St. Louis. Seconded by Helen Scott, the motion carried. After the Memphis shows we will ask for volunteers for the New York specialty Show Committee.

Jennie Wright made a motion that new title awards only go out to the primary owner, and if they do request one for the co-owner we will send one out. Seconded by Gloria Robinson, motion carried.

Bob Owen explained that at one time we voted to do away with the CHIC testing tied to the Awards, but then the suspension negated that. A new motion was then made to allow the members to vote on whether they want to do away with the CHIC testing connected to the Awards. Meanwhile we still have the CHIC connected to the Awards, and people are going to start wondering what happened to this issue. The membership will be given an opportunity to vote on this issue, along with the DQ, and the By-Laws. We will need changes on the application for the awards, and it will take time. Jennie Wright will send the suggested changes to the Board. Bob Owen made a motion that we rescind having the CHIC number tied to the Awards for 2013 until the membership has an opportunity to vote and revise it. Seconded by Carolyn Hensley. Voted on, motion carried. Opposed: Charlie Farrar.

Bob stated the Canine Chronicle wanted information for their data base for the all time winning dog and bitch in Yorkshire Terriers, based on career top numbers of best in show. Bob and Helen feel they can come up with it.

A motion was made by Gloria to adjourn the meeting. Motion carried. Meeting adjourned at 10:06 Eastern time.

MINUTES OF MEMBERSHIP MEETING

HELD ON WEDNESDAY, SEPTEMBER 18, 2013

AT THE NATIONAL ROVING SPECIALTY, MEMPHIS

The meeting was called to order at 6:30 pm at the Whispering Woods Hotel & Convention Center, 7300 Hacks Cross Road, Olive Branch, Mississippi, the venue of the YTCA National Roving Specialty.

The meeting was called to order by Bob Owen, who became president due to the resignation of Cheryl Rangel. Bob welcomed everyone to the cluster shows, and announced various activities that would be taking place. In particular he thanked the hospitality committee for the wonderful job they were doing, and to the Roving Specialty Committee for the beautiful decorations.

A sign in sheet was distributed with only sixteen (16) members signing. Although there were approximately 35 people in the room, some were spouses of members, and others visitors. Some members declined to sign in. A quorum was not met, however the meeting continued with no motions, or voting taking place.

In the absence of the Secretary, Bob Owen requested that Gloria Bloch-Robinson, secretary's assistant, take the minutes of the meeting. Minutes of the previous membership meeting were accepted as published.

Jennie Wright announced that in the case of more than one owner of a dog being recognized by the awards committee, the first owner would receive the actual award, and if the other owners wanted an award they may have one upon application. Two owners who lived in the same household would receive only one award.

We received the sad news that Dr. Dale Heisler DVM had passed away. Dale joined YTCA in the year 2000, and contributed articles and information in the Express. Condolences were sent to the family.

President's Report

President Bob Owen announced that several items were being prepared for a ballot by the membership and they would all go out together. One item was to vote on potential judges for three shows, both sweepstakes and conformation. A second issue requiring a vote on the wording of the DQ, it has been published in the Express, and this will require a two thirds majority. A third item on the ballot will be the requirement of CHIC for the top dog award which was voted in during the club's suspension and will require a revote.

It was announced that the New York Specialty will be held at the _____ in Times Square, and AKC is working on getting a shuttle from the hotel to the Progressive.

Treasurer's Report – none at this time.

Program/Speaker – Eddie Dziuk (CEO of OFA) presented a program on the importance of health testing and the CHIC program. He stressed the main reason for CHIC testing was to provide a data base. Parent clubs are encouraged to emphasize health testing and YTCA joined in the program in 2008. The only requirements for our members to be recorded under CHIC are 1) Patella's, and (2) Eyes. A question and answer period followed Mr. Dziuk's presentation.

Show Committee

Ken Lambert invited everyone to attend the dinner beginning at 7 pm, and also visit the hospitality suite in the Cherry Room at the hotel, hosted by the Roving Committee.

By Laws Committee

President Owen announced the By-Laws committee consisting of Marie Kaufman-Cardona (chairman), Martha Green, and Sharon McCadam.

One item announced is that foreign members who paid their dues through the 2012/2013 year will retain their voting rights. Any new foreign membership applicants will come under the new rule of no voting rights.

Awards Committee

Jennie Wright announced that the Awards application form will be posted on the website and can be printed to use to apply.

There being no further business to discuss, the meeting adjourned.

Board members present and voting Owen, Meadows, Doss, Fallon, Lambert, Rogan, Scott, Wright. Vote count was 6 yes, 2 no.

The board made the final ruling on the matter of a complaint made by member Farmer against member Hensley and subsequent hearing committee findings. The board ruled by majority to reject and not to execute the punishment portion that was recommended by the committee. Board members present and voting Owen, Meadows, Doss, Fallon, Lambert, Rogan, Scott, Wright. Vote count was 6 yes, 2 no.

MINUTES OF THE PREVIOUS MEETING:

The minutes of the August 14, 2013 Board Meeting were approved by the majority and a hard copy received.

PRESIDENT'S REPORT: President Robert Owen welcomed the new members Vicki Meadows-Vice President, Pat Fallon-Treasurer and Wendy Doss-Secretary to the board.

SECRETARY'S REPORT:

Secretary Wendy Doss reported that she received a copy of the sign in sheet from the Membership meeting held at the roving specialty in Memphis, September 18, 2013, and a copy of the minutes as taken by Gloria Bloch-Robinson, Assistant to the Secretary in her absence.

TREASURER'S REPORT:

Treasurer Pat Fallon reported that she is new on the job, and that she filed the California franchise taxes and they have been paid, and the accountant filed the 990-N. She received all the checks from Bob and Pam Wengorovius. Ken Lambert is sending her all of the vendors checks from Memphis. She received two dues renewals from Charlie Farrar. She will have a report when she has everything together. Bob has signed all of the signature information for the bank and mailed it off.

REPORTS OF COMMITTEES

SHOW COMMITTEE:

Jennie Wright made a motion to keep Cheryl Rangel as the show chair and show secretary for the YTCA New York specialty, Feb. 2014. Helen Scott Seconded. The motion passed unanimously.

Bob Owen reported that he has contract from MB-F he needs to sign and return. They will do our mailing of premium lists and will take entries. They also can provide a service to list the show results online for .50 cents per dog.

Vicki meadows made a motion, seconded by Ken Lambert to have MB-F list the results online on Infodog, the motion passed unanimously.

Cookie Rogan suggested that we have the New York specialty results put on the YTCA announcement list. This was discussed and we will try to work out a way to get this done.

New York Hotel: Pat Fallon will provide the needed credit card information to the Crown Plaza Hotel to deduct the next deposit in November.

WEBSITE: Ken Lambert reported that Content Management is an option that we can use through GMR which will allow editing of the website by one of our own volunteers. This option has a \$975 dollar one time fee. That would eliminate the \$135 dollar monthly fee that we are paying or any overage charges, and just have the \$20 dollar hosting fee, or fees for any major changes. This will save the club \$405 dollars a year and give us the ability to update our website as needed.

Jennie Wright made a motion that in order to save at least \$405 dollars per year in website charges, that we let Ken Lambert, assisted by Lisa Thornburg and Terri Van Kirk and under the YTCA board, use the option for content management on the website. The motion was seconded by Vicki Meadows. The motion passed unanimously.

Wendy Doss suggested that we list the user name and password for entering the member's only section of the website in the YTCA roster. A discussion was held and it was agreed that this is a good idea and will be included in the next edition of the roster, along with being published quarterly in the E Express in case there is a need to change it.

BREEDER REFERRAL: Bob Owen reported that Cindy Whitehead had resigned as chair for the breeder referral committee, and also from the committee that sends out the clear plaques to the specialty clubs for their shows. Ken Lambert will put a page in the E Express for volunteers.

COMPANION EVENT COMMITTEE: Bob Owen reported that Joanie Carl resigned from the Achievements Awards Committee Chair and that Faye Mitchell has been appointed the new Chair of this committee.

ROVING COMMITTEE: Ken Lambert is heading this committee along with Cheryl Rangel. Performance volunteers are Judy Casserberg and Faye Mitchell. Carolyn Hensley suggested that we ask for more volunteers and it will be sent to the announcement list. We are currently looking at some good offers for holding the roving specialty in 2014.

AWARDS COMMITTEE:

Jennie Wright made a motion that beginning with the year 2013 awards, that all year end awards must be applied for, seconded by Cookie Rogan . Motion passed unanimously.

Jennie Wright made a motion that beginning with the year 2013 awards, that we offer an award for the **AKC** Top Owner-handled dog and bitch, Carolyn Hensley seconded, the motion passed unanimously.

Jennie Wright made a motion that the awards application is to be to put in the E-Express and put on the website. Wendy Doss seconded, the motion passed unanimously.

UNFINISHED BUSINESS

BALLOTS: The ballots for voting on the DQ wording, Judges selection list (top ten for regular class judge and sweeps) and CHIC requirements will be going out as soon as they can be prepared by the Secretary.

JUDGES EDUCATION: Packets from Kathleen Kolbert were received by Bob Owen regarding AKC judges mentoring program.

NEW BUSINESS

AKC DELEGATE: The board received and accepted the resignation of Pat Reynolds as our AKC Delegate. The board will put out an announcement for anyone interested in doing this job to contact them.

HEARING COMMITTEE and ATTORNEY BILLS: Jennie Wright made a motion to pay the parliamentarian invoice submitted by Cheryl Rangel for \$250.00. Helen Scott seconded. The motion passed. Voting yes Owen, Meadows, Doss, Fallon, Lambert, Rogan, Scott, Wright. Abstain Hensley.

Vicki Meadows made a motion to pay the California attorney bill from Ortega for \$100.00 regarding the corporate suspension in California. Carolyn Hensley seconded. The motion passed unanimously.

Ken Lambert made a motion to pay the South Carolina attorney bill submitted by Lisa Bridgewater in the amount of \$440.69. Vicki Meadows seconded. Voting yes Owen, Meadows, Doss, Fallon, Lambert, Wright. Voting no Hensley, Rogan, Scott.

Ken Lambert made a motion to pay hotel, parking and meal bills for a total of \$300.22 submitted by Julie Howard. Rental car, parking, and gas bill submitted by Lisa Bridgewater for a total of 76.84. Helen Scott seconded. Voting yes Owen, Meadows, Doss, Fallon, Lambert, Scott, Wright. Voting no Rogan. Abstain Hensley.

Ken Lambert made a motion to adjourn the meeting, Helen Scott seconded. Motion passed unanimously.

DELEGATE REPORT
SEPTEMBER 9-12, 2013
NEWARK, NJ



On Monday morning, September 11, at 9:00 a. m., I attended the Parent Club Committee meeting. There was a short discussion of **the new Parent Club of Excellence Award/designation.** It was announced that a few tweaks were being made and the program should roll out shortly. **The Complete Dog Book has been sent to the publisher and galley sheets will be sent to the club's responsible liaison for final review.** A total of 11,500 CGC titles have now been awarded. Due to the popularity of this program a new CGCA (advanced) title is now also available, although there will be no certificate issued for this one.

E balloting is now officially available to club. To utilize this clubs will need to ascertain first if it is allowed by the corporate laws in their state of incorporation and would then need to amend their bylaws by the necessary vote to implement it. It could result in significant savings to clubs, as some companies charge as little as seventy-five cents per ballot. It was suggested that in choosing the entity to provide the service that clubs consider using one that also handles the paper ballots so there is not an issue of coordination of the two forms of balloting, as there will be those members who will not sign to accept the e-ballot format.

The AKC Pet Disaster Relief project, being handled through AKCReUnite (formerly CAR) is a reality now, only 91 days after the concept was first brought forth. Much information is available on the AKC website, and clubs are urged to get their logos on the sides of the trailers by making donations now, which, since going to AKCReUnite, will be tax deductible. Several clubs actually made pledges at the meeting, and trailers are already on their way to the most critical parts of the country.

Meet the Breeds is set to occur again in Orlando. All clubs are urged to participate.

Clubs with active rescues may apply to the AKC Humane Fund for grants up to \$1,000 per year. A showing of actual rescue work done and expenses incurred are required to receive these grants.

There were two announcements of news outside AKC. First, there has been much coming out recently about how **shelter dogs are becoming a "for profit" business,** with shippers moving the dogs from the Midwest and the South to the East Coast. Second, **the President recently stated he opposes any breed specific laws based on information from the CDC.**

At the **Perspectives committee meeting** we went over the various article for the December edition. It was also announced there that I had been re-elected to the committee for two more years as no one ran against me.

At 1:00 p.m. **I attended the Bylaws Committee meeting.** **The primary discussion there concerned opening up the delegate qualifications to allow anyone except commercial breeders and brokers to serve as a club's delegate.** At present judges who charge, professional handlers, dog food manufacturers and sellers, and those who are full-time

superintendents, among others, are excluded from being approved as delegates. The committee approved no language for submission, so this is still just something under consideration.

Also discussed was **the possibility of a new committee, most likely an ad hoc committee, to explore the issues of judging policies.**

The final topic discussed was the idea of **allowing people from outside the dog fancy and outside the delegate body to serve on the AKC board.** The general consensus was that this was not a good idea, and that it would be better for the present process of using such people as consultants to the board to continue.

I attended the Delegate Caucus at 3:40 p.m. Issues discussed included **the upcoming NAIA conference in Orlando in November, the reasons that Eukanuba was no longer going to be televised** (due to live streaming instead, as decided by the sponsor), **problems clubs were having getting shows approved** (lost papers no answers, wrong answers), and **classes for altered dogs and bitches.**

The Dock and Crop meeting was held at 4:30 p.m. It was announced that there had been no response received regarding the question as to why the **Eukanuba World Challenge, although held in the U.S. in Orlando, Florida, utilized FCI standards for their judging.** Per AKC's own rules **judging must be done by the standard in effect for the breed in the country where the show is held, with the exception of breeds not recognized yet in that country, in which cases another standard would obviously be allowed.** It was again reported that club needed to actively advise Neil Singer at AKC that there clubs do not appreciate the promotion of Crufts by AKC and that they need to advise him **in writing declining the Crufts certificates for their breed at their national and at Eukanuba due to Crufts refusal to recognize the parent clubs' breed standards.**

The Coordinating Committee was from 5 to 6 p.m. I again missed the first part of this meeting due to the Dock and Crop meeting running past 5 p.m. It was announced that **the June 2014 Forum will be on the use of social media by our clubs to our best advantage to solicit new members and to encourage participation in our events.** It was announced that the Pembroke Corgi Club, the Tibetan Mastiff Club, and the Chattanooga Kennel Club had pledged \$5,000 to \$10,000 each to assist with the Pet Disaster Trailer Project.

The general delegate meeting was called to order at 10:00 a.m. on Tuesday, June 11. The meeting opened with voting for the committee seats.

The **Chairman's Report by Alan Kalter** dealt with **the new "I love my breeder"** campaign by AKC. AKC continues to work with and implement the ideas developed with the new PR firm, Edelman.

President Dennis Sprung reported that **the AKC Humane Fund is growing and available for grants, including to rescue groups. It also aids those in women's shelters to keep their pets with them.** He also reminded everyone of the **Breeder to Breeder seminars to be held at Eukanuba this year on December 12 and 13.** It features free seminars on genetics, pedigrees, whelping, and many other topics of interest to AKC breeders. The fact that the seminars will be taped will make them widely available to help those who want this expert knowledge.

Chief Financial Officer Peter Farnsworth gave the latest financial report. Revenues are up somewhat, costs continue to be contained, but registration are still continuing to decline, although more slowly than in the past.

The only matter to be voted on at the meeting was an amendment to Chapter 4, section 2 of Dog Show Rules to eliminate varying time frames to send out premium lists. The amendment passed by the two-thirds needed to approve the same.

The meeting ended **with a wonderful video and slide presentation on the disaster relief trailers. I urge our club to raise money for this project. One never knows when the need will arise in your own community, and it will be wonderful to know that these trailers are there, stocked and available to save the lives of pets in the midst of disaster, whether the disaster is a fire, tornado, hurricane, or earthquake.**

Under new business the idea of **having information on the disaster trailers at Meet the Breeds was brought up and it was suggested that jars could be put at the various tables to collect funds.** Clubs were urged by Pat Laurens, chair of the Parent Club Committee, to **raise money for the disaster trailers at their national shows** Concern was expressed by a delegate for a dog training club that the AKC telephone training help line was competing with the work of clubs such as hers.

The committee election report was given.

Meeting was adjourned thereafter at 12:10 p.m.

As a final part of this report, I want to say what a wonderful experience it has been for the past seven and a half years to represent the breed that I love in the capacity of being your delegate to the AKC. I have worked with some wonderful board members over the years, including presidents Janet Jackson, Carl Yochum, and Cheryl Rangel and the other officers and board members who served with them. I feel, however, that with the composition of the present board, I no longer have the rapport needed with the majority of the board to properly serve this club as your delegate. Therefore immediately after my return from the delegate meeting reported on above, I tendered my resignation as the delegate for our club. I wish the next delegate all the best, as well as the best for our club and our breed in the future. I look forward to finding other ways to serve the club and our breed.

The Premonition

Who can see into the future and know what things are about to happen? The Irish call it “fey”, yet others call it a woman’s intuition, but sometimes it is just plain premonition. In this case a friend and fellow Rescue worker, a Native American Indian, had a feeling something was missing from our Rescue program and brought it to our attention.

It came about by the untimely death of a past member of our club, a fellow Yorkie exhibitor and breeder. He had not been seen for several days and a friend couldn’t reach him on the telephone so he drove for a couple of hours to his home and made the discovery.

Distressing also was the fact that his family of canines had been unattended for four or five days and it was a miracle that they were still alive although they had not been fed in all that time. Luckily, water bottles on their plypens avoided dehydration. There were many dogs to care for and Rescue was called to help with the task. Central Florida Yorkshire Terrier Club Rescue took in nine of the dogs, mostly under the age of six years, and they were surprisingly healthy considering what they had been through. It was a big expense on Rescue and a huge task for the workers to obtain necessary veterinary care for each dog to have them spayed and/or neutered and placed in new homes. We are forever grateful to our veterinarians and their attending staff, who worked on their days off to accomplish this task.

Sorry for getting side tracked ...

It was Talleah Allen, otherwise known as Lea, who spoke up at a rescue meeting one day and wanted to know if we had a written plan for folks to follow in the case the unthinkable happened causing an emergency placement of our dogs. We all looked blank and realized that none of us were prepared for such a circumstance. So Lea suggested we put together a plan or guideline and draft a “Disposition of Canine Family” document.

The following document is the result of several months of work on behalf of our CFYTC Rescue group. One must remember that this is a “guideline” because laws differ from state to state or from country to country. The information will give you something to think about.

The following actions should take place in order to accomplish the goal of your document.

- 1) All the dogs should be micro chipped. Identification is the most important issue and one that cannot be overstated. There should be no room for error and micro chipping is a good way of identification at this point.
- 2) All registrations should be copied, the originals signed by owners/co-owners and placed under lock and key and the copy kept for everyday use. If the originals are not signed when a person dies, it takes considerable time to go through the legal process with AKC to reassign ownership.
- 3) Paperwork involving each dog should be in a file appropriately identified by the dog’s call name, AKC Registered name, and microchip number identification. Included should be all the health records, any testing records and whelping or stud records. This is especially important if the dog has any health issues that will need attention at any time.

- 4) Once the Disposition of Canine Family has been completed with appropriate attachments, it should be signed in front of a legal representative or a notary public. A copy of the Disposition of Canine Family should be placed in each dog's file. If Rescue is to be responsible for any placement, a copy should be filed with Rescue also. It goes without saying that this document should become part of the Last Will of the owner.

So far this sounds simple and according to common sense. It wasn't until the unthinkable happened to Lea that we learned even more about pre-planning. Lea was diagnosed with lung cancer -- a particularly virulent type of cancer. She had worked as a Director at the University of Central Florida in Orlando for many years and being the breadwinner of the family, she was determined to keep working while undergoing surgery, chemo, and radiation treatment. Lea also knew that she needed help with her dogs while undergoing treatment and she arranged for several of our Rescue group members to foster those dogs she wanted to keep until she was feeling better. Lea designed a "Foster Contract" to cover this action

Then Lea stepped back and took a concerned look at the older dogs or those that were her "bed buddies" and made the heartbreaking decision of those she needed to place. Lea only had ten dogs but several needed to be placed in new forever homes. Each dog was assessed by Lea and released to Rescue one or two at a time, until only two "bed buddies" remained plus three potential show dogs that were being fostered. At the beginning of the process, Lea decided to open a special bank account to cover the needs of the dogs if and when Rescue took them in, which turned out to be very helpful. A Rescue team member was a co-signer on the account.

Everyone was praying for the best outcome, but it wasn't to be and all of Lea's dogs had to be taken care of in accordance with her wishes. CFYTC Rescue followed her written instructions to the letter, there was no room for any deviation and while we mourned for Lea we felt we had accomplished her designated instructions exactly as she wished. Even the show potentials were retrieved from foster homes and sent to their designated new homes.

When Lea fell to sleep that final day, she had her two bed buddies with her at the end. Thereafter, they were transported to their new homes. Lea was at peace knowing her canine family had been taken care of to the best of her ability. She had been a part of the process all the way; she had received notes and photos from new owners and knew that Rescue did their job.

You must designate someone you trust to care for your canine family. While this is not the usual Rescue operation, there is no reason why Rescue cannot be there to help club members when the need arises. Lea gave us far more than we anticipated when she designed the emergency action plan. It's never too early to put your plan together.

The attached "Disposition of Canine Family" is the document that Lea used; however, not everyone's circumstances are the same; therefore, you may need to design one specifically for your particular circumstance.

DISPOSITION OF CANINE FAMILY

BE IT KNOWN TO ALL PERSONS, that I, _____ do hereby bequest that all my dogs (bitches, dogs, and pups), here in after referred to as dogs, be signed over to the Central Florida Yorkshire Terrier Club (CFYTC) in the event of my untimely death.

The CFYTC Board of Directors will be responsible for either placing the dogs with current club members with AKC papers, or re-homing them without AKC papers, as they see fit. If there are show prospect dogs, the club members who take possession of the dogs may show them to their championship and then breed them if they so wish. However, new owners must agree to each bitch producing only three (3) litters and only AKC registered mates may be used for such breedings. Should a dog, for any reason, not be show material, then the Board of Directors will have the right to decide whether (a) to allow breeding to take place, or (b) to spay/neuter the dog and place him/her into a loving pet home.

Under no circumstances may any club member sell any dog received through this process. If for ANY reason, the new owner regardless of cause cannot keep the dog, the Board of Directors will take possession of the dog and determine placement options. No family members, unless approved by the board, may take possession of any of the dogs.

Any dogs that are placed in pet homes must be neutered/spayed and micro-chipped or tattooed if not already done so, then placed at a cost that will ensure the club recovers any and all expenses incurred. No dogs may be sold or placed by the new adoptive owners. If the adoptive owners do not keep the dogs, they MUST be returned to the CFYTC and the Board of Directors will take possession of them until placement options are determined.

Should there be any dogs that are very old at the time CFYTC takes possession, the Board of Directors may determine the most humane option for placement or disposition.

Under no circumstances will any dog be euthanized if the quality of life is still good. The board will make every attempt to place older dogs into loving homes. The board and club members will take a vote to determine the final fate of any older dogs before euthanasia is selected.

Should a member of the family request to take possession of any dogs, the Board of Directors of CFYTC shall have the final decision as to whether this can take place. If the Board of Directors approves such action, only ONE (1) dog may be given to the family member and the dog selected by the board will be neutered/spayed prior to placement.

All dog grooming and show items/equipment might be bequeathed to the CFYTC to do with as they see fit.

An accurate record of placement, maintained by cross-reference of micro-chips or tattoo on dogs, will be retained in the CFYTC and periodic visual checks should be made to ensure the dogs are well and happy. If at any time, it is determined that the dogs are not being cared for appropriately, the CFYTC will have to right to remove them from the new owners and find other suitable homes. A signed

copy of this document or equivalent contract will accompany the placed dogs making it a legal document in the event that removal is necessary.

YTCA Foundation's Canine Cancer Campaign

Join the fight against Canine Cancer

Recently, we received information from the AKC Canine Health Foundation's campaign against Canine Cancer, and the YTCA Foundation decided to provide a grant in the amount of \$10,000 to be equally divided between these two research projects: #1889-G: Developing Markers to Diagnose and Guide Cancer Treatment in Golden Retrievers Based on Newly Discovered Heritable and Acquired Mutations and #1918-G: Discovery of novel protein, blood, and epigenetic biomarkers of lymphoma risk, classification, and prognosis in Golden Retrievers (See this website for more information <http://www.akcchf.org/news-events/news/chf-grf-funding.html>)

This is the reason for our decision to fund a grant for Canine Cancer instead of other issues that involve the Yorkshire Terrier primarily: the Foundation (as well as other organizations) have spent a lot of money in the past supporting grants that will never come to fruition, even though they are hot button topics in our breed. Breeders are fast becoming aware that only we can prevent the transmission of lethal genetic diseases by screening the best way we can. Not only that, we must resist the temptation to breed a spectacular specimen of the breed even though it probably carries the deleterious genes. The problems of liver diseases, GME, etc., begins and ends with us as we practice artificial selection through our breeding programs.

So where do we go from here? Dr. Jerold Bell and other geneticists have pointed out that over 75% of the genes of all breeds are probably identical - these are the genes that make the species *Canis familiaris*. Only a small percentage of genes code for the characteristics of individual breeds, like the Yorkshire

Terrier or Golden Retriever. Therefore when we support grants targeting other breeds, we are quite often really helping our own Yorkies, too. (See this website for more information <http://genome.cshlp.org/content/15/12/1706.full> on the canine genome project.)

Across the breeds, cancer is a huge problem - the YTCAF has sponsored grants on lymphoma, etc. before. One recent study from the UK found that almost 16% of canine deaths were due to cancer - and this is twice the number of cardiac problem deaths. A study from Denmark found virtually the same thing. And the head of CHF has stated that almost 1/3 of senior dogs will die of cancer here in the U.S. But now we have an opportunity to help not only dogs but ourselves! The new AKC/CHF Canine Cancer initiative has as its researchers top scientists in genetic research and cancer. This is one of the rare times when information is flowing both ways - advances in human oncology are being used to help dogs AND vice versa.

We used to always hear of the "Big C" - everyone thought that cancer was a specific disease caused a specific way. Now we know that cancer simply means the uncontrolled growth of cells that no longer commit suicide when their programmed life span should end. And this uncontrolled growth can occur anywhere in the body. Some of this is caused by genetics, but most is caused by environmental factors that we have brought on ourselves and our dogs, the old "nature vs. nurture" debate.

So now the YTCA Foundation has an opportunity to be a small part of a really big picture to help dogs and their owners/breeders. We should all join the fight and contribute to scientific endeavors that will benefit us all!

The Purina Parent Club Partnership (PPCP) Program allows national parent breed clubs to individually earn funding based on Purina weight circles submitted by Purina Pro club members. Purina places 1/2 the monies earned from the weight circles into the YTCA treasury and the other half is deposited into the AKC Canine Health Foundation's (CHF) Donor Advised Funds (DAF).

Purina states that they deposit money into the DAF to support research grants aimed at a better understanding of genetics and other conditions impacting our dogs' health. The other half is issued directly to the national parent club, YTCA in this case, for use in support of canine health, education, scholarships, and/or rescue efforts.

Although the program has been in existence since 2002, from the years, 2006 - 2012, Purina has donated to Yorkshire Terriers \$48,545.68 -- half went to the YTCA Treasury and the other half to the DAF at the CHF (\$24,272.86 each). The largest amount of monies was in 2008: \$8,980.07, again split in half.

To be eligible for the PPCP Program, you must be in the Purina Pro Club which requires you are the breeder/owner/caretaker of 5 or more dogs. You can sign up on line with Purina at PPCP. Once in the club, the person must designate their breed before sending in weight circles. You can collect weight circles from friends, puppy buyers, neighbors who feed Purina. There are about 220 DAFs for breed clubs or breed club foundations. 9 breeds have their parent club foundation responsible for the DAF. 16 breeds have two separate DAFs between the parent club and their foundation. Although there are a few breeds who have no foundation, in most cases, the parent club and their foundation work together in sponsoring grants with CHF together that benefit their breed. Foundations were initially established to make contributions to the foundation fully tax deductible under the law.

As a matter of information, the Foundation works very close with Purina on health articles for their breed columns and you will find several of these columns on our website: [yorkie health foundation.org](http://yorkiehealthfoundation.org).

In view of the dwindling interest in cutting these circles, we would like to start a campaign to revitalize the participation of Yorkie fanciers in the program. If we remind, not just YTCA members, but our puppy buyers, Yorkie enthusiasts, other list members, boarding kennels, veterinarian offices of how important participating in this program can be, I am sure we can renew interest in it and have more money coming in from Purina to benefit Yorkshire Terriers. We know that all Yorkie owner would like to make our breed healthier. So, will you take the time to cut these weight circles? If you cannot join the program or do not wish to do it yourself, please send these circles to any Foundation member and we will be glad to periodically send them in to Purina. Let's make this everyone's New Year's resolution in behalf of our precious breed and to promote a healthier tomorrow for our beloved animals.

IN AN EMERGENCY SITUATION such as a heart attack, drowning or fall, the victim should be responded to in an appropriate manner. Administer CPR (if certified) and an ambulance should be called by dialing 911.

Try to notify next of kin or a friend traveling with the group.

DISASTER EVACUATION PROCEDURES

1. In the case of a severe weather storm or other instances not including a fire evacuation, leave your room immediately and head for the nearest stairwell.
2. Go to the Main Lobby area of the hotel and wait for further instructions
3. Do not stand near any windows
4. Utilize the same system for removing your dogs from the room (a large pillowcase) unless you are able to carry the crate with you. Take your room key
5. Follow instructions from hotel management and/or fire and police personnel

DOG EVACUATION PROCEDURES

1. In the case of a fire or other evacuation, have a king size pillowcase nearby. Place as many dogs as possible in the pillowcase and twist the top. This will enable you to carry them out of the building safely. There is no chance of suffocation to the dogs inside the case
2. It's a good idea to keep a few leads inside the case. When you reach the outside you have some way to keep control of the animals
3. Do not endanger your life or the lives of others in your room by spending time searching for your dogs. If they are properly penned or crated, you should be able to gather them quickly and easily.

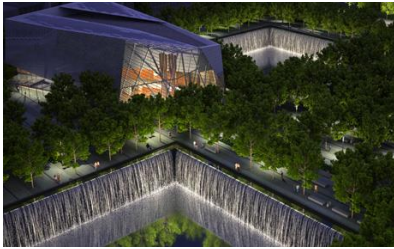

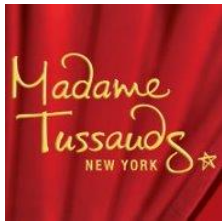

Official Standard of the Yorkshire Terrier

As with all purebred dogs recognized by the American Kennel Club, there is an approved Breed Standard for Yorkshire Terriers. This standard of perfection is a written description of how the ideal Yorkshire Terrier should look. All responsible breeders strive to produce dogs that conform to this Breed Standard. Yorkshire Terriers with major deviations from that Standard in appearance should not be bred.

General Appearance

That of a long-haired toy terrier whose blue and tan coat is parted on the face and from the base of the skull to the end of the tail and hangs evenly and quite straight down each side of body. The body is neat, compact and well proportioned. The dog's high head carriage and confident manner should give the appearance of vigor and self importance.

Head

Small and rather flat on top, the skull not too prominent or round, the muzzle not too long, with the bite neither undershot nor overshot and teeth sound. Either scissors bite or level bite is acceptable. The nose is black. Eyes are medium in size and not too prominent; dark in color and sparkling with a sharp, intelligent expression. Eye rims are dark. Ears are small, V-shaped, carried erect and set not too far apart.

Body

Well proportioned and very compact. The back is rather short, the back line level, with height at shoulder the same as at the rump.

Legs and Feet

Forelegs should be straight, elbows neither in nor out. Hind legs straight when viewed from behind, but stifles are moderately bent when viewed from the sides. Feet are round with black toenails. Dew claws, if any, are generally removed from the hind legs. Dew claws on the forelegs may be removed.

Tail

Docked to a medium length and carried slightly higher than the level of the back.

Coat

Quality, texture and quantity of coat are of prime importance. Hair is glossy, fine and silky in texture. Coat on the body is moderately long and perfectly straight (not wavy). It may be trimmed to floor length to give ease of movement and a neater appearance, if desired. The fall on the head is long, tied with one bow in center of head or parted in the middle and tied with two bows. Hair on muzzle is very long. Hair should be trimmed short on tips of ears and may be trimmed on feet to give them a neat appearance.

Colors

Puppies are born black and tan and are normally darker in body color, showing an intermingling of black hair in the tan until they are matured. Color of hair on body and richness of tan on head and legs are of prime importance in adult dogs, to which the following color requirements apply: BLUE: Is a dark steel blue, not a silver blue and not mingled with fawn, bronzy or black hairs. TAN: All tan hair is darker at the roots than in the middle, shading to still lighter tan at the tips. There should be no sooty or black hair intermingled with any of the tan.

Color on Body

The blue extends over the body from back of neck to root of tail. Hair on tail is a darker blue, especially at end of tail.

Head fall

A rich golden tan, deeper in color at sides of head, at ear roots and on the muzzle, with ears a deep rich tan. Tan color should not extend down on back of neck.

Chest and Legs

A bright, rich tan, not extending above the elbow on the forelegs nor above the stifle on the hind legs.

Weight Must not exceed seven pounds.

Disqualification

Any solid color or combination of colors other than blue and tan as described above. Any white markings other than a small white spot on the forechest that does not exceed 1 inch at its longest dimension.

PREFACE

As a member of the Yorkshire Terrier Club of America, inc., I agree to uphold the principles of the Club's Constitution, Bylaws, Code of Ethics and Code of Conduct and will protect the interests of the Yorkshire Terrier in the manner reflecting credit to myself, the Breed, and the Club. I agree to comply with all AKC Rules and regulations.

While understanding that the circumstances facing each individual member are different, the Codes set forth a standard of canine husbandry all Club members should strive to achieve.

The code is intended to provide each member fundamental behavior principles which will guide the Club, the Yorkshire Terrier breed and each member well in nearly all situations.





Yorkshire Terrier Club of America, Inc. Code of Ethics

- 1) A breeder-member shall strive to conform to the Yorkshire Terrier Standard as approved by the American Kennel Club, to improve progeny, and to reduce faults to a minimum.
- 2) Members shall comply with the rules of the American Kennel Club concerning record keeping and the registration, identification, sale, and transfer of dogs.
- 3) Members shall refer potential puppy purchasers to other reputable breeders and be helpful and courteous to those who request information about the breed
- 4) All contractual terms and conditions relating to Yorkshire Terriers shall be reduced to writing and shall be honored by a member..
- 5) All stud dogs and bitches shall be screened prior to breeding for both infectious and hereditary diseases using the currently accepted and available techniques.
- 6) A breeder-member selling puppies or offering stud services shall fully disclose to potential clients any serious or disabling hereditary defects, including the reasonable possibility of such defects. Such health defects shall be stated in writing.
- 7) A member shall not defame another member or the YTCA nor seek to impair a member's or the YTCA's reputation, provided however, a member shall report any serious situation, created by another member, that is detrimental to the breed or is inconsistent with these principles. This report should be in writing and sent to the Club Secretary.
- 8) A member's advertising: -shall be professional in appearance and location; -may refer to YTCA membership but may not misuse YTCA membership to attempt to enhance integrity or the quality of stock; -shall not contain any misleading photograph or other graphic materials; -shall not use terms such as "teacup", "tiny specialists", "doll faced", or similar terminology.
- 9) Members shall sponsor an applicant for membership only if the member has personally known the applicant for a minimum of two years. At least one of the sponsoring members must have visited the applicant's facility one or more times during the two years immediately preceding the application date. Sponsorship is not to be taken lightly. Each sponsor must understand YTCA and the Yorkshire Terrier are represented by each and every member individually, and careful consideration should be given to each candidate.

CODE OF CONDUCT

- 1) Assistance and encouragement shall be willingly offered by members to Show Novices and others needing advice and guidance. The welfare of the breed will be in their hands in the future.
- 2) All dogs will be kept under safe and sanitary conditions, be given proper nutrition, protection, and maximum health care including regular inoculations as advised by the member's veterinarian.
- 3) Healthy spacing between litters will be a priority and unspayed bitches will be protected from unplanned matings. Bitches will in no case be bred before their second heat or before they are at least eighteen (18) months of age, whichever comes first, nor be placed at risk by an unreasonable number of cesarean sections and then only with the concurrence of a veterinarian.
- 4) Puppies will not be sold or consigned to pet stores, agents, or other commercial enterprises nor sold to disreputable breeders, and neither puppies, adult dogs, nor stud services will be offered as prizes or for raffles.
- 5) Prospective buyers will be screened as thoroughly as possible to determine their intent, as well as their ability and interest in providing a safe, adequate, loving environment and a long term relationship with a puppy or adult dog.
- 6) All puppies and dogs offered for sale will be sold with written sales agreements to include clear terms and conditions and be signed by the seller and buyer. The contract will request that the seller be contacted in the event that at any time the owner is unable to keep the dog, it will be the obligation of the seller to assist in the placement of the dog in question.
- 7) Purchasers will be required to neuter/spay all puppies sold as pets. If specified in the written sales contract, the seller will promptly release limited registration forms upon receipt of a veterinarian's certification of such spaying or neutering.
- 8) All puppies leaving the breeders possession will be a minimum of twelve (12) weeks of age to facilitate adequate socialization as well as appropriate emotional and temperament development through interaction with siblings, dam and other dogs.
- 9) Breeders will provide puppy buyers with written details of feeding, general care, date and types of a minimum of two (2) inoculations, as well as dates of wormings, grooming instructions, etc. and be available to offer future advice as needed.
- 10) Stud service will be offered only by and to AKC Full Registered, or registered with an AKC approved foreign registry, healthy, mature dogs and bitches, respectively, and only of sound temperament. The dogs and bitches should be free of serious congenital and hereditary defects. Stud service will be refused for any mating which is considered to not be in the best interest of the breed which includes dogs and bitches with Q Registration in their pedigrees, and dogs and bitches of any color, or combination of colors not specified in the standard. Members will not sell dogs of such colors as exotic or rare.
- 11) Animals recently exposed to the risks of infectious diseases and bitches with nursing whelp will not be exhibited.
